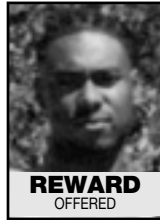

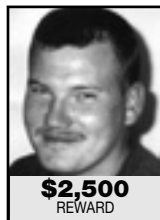


Name: Deon Antwain Jerido

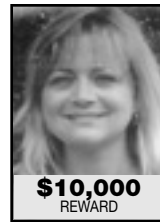


Name: Cejay L. Davis
