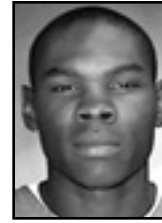
Name: Shelton Flowers

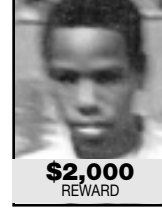

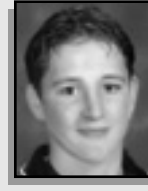
