believe that somewhere in the hunting club, Terry was shot and his body was disposed of. It is believed that, after the shooting, Cornwell drove Terry's Pathfinder out another gate and went back to the gate where his truck was parked. He parked and locked the Pathfinder and then left the area in his truck. Terry's ring of gate keys was still on the front seat of the Pathfinder when it was recovered.

James Cornwell was interviewed subsequent to Terry's disappearance, but denied knowledge of what happened to him. He was asked to take a polygraph test, but refused. On October 10, 2002 at approximately 7:45 p.m. he ended his life by putting a gun to his head.

We believe that Terry's body is still somewhere in the River Bend Hunting Club area, and are asking for help from anybody hunting there to be especially watchful for anything that might lead to its recovery. **A reward has been offered.** If you have any information, no matter how small, please contact T.E.
