Paul W. Seidenstricker was murdered on February 21, 1994. He was on his way home from work when an unidentified man in his car stabbed him multiple times in a robbery attempt. He later died alone at University Hospital while his wife and children slept.

The past fifteen years have not been easy. Paul missed out on so much with his children. He did not get to walk his daughter down the aisle when she got married or hold his three beautiful grandchildren in his arms. His son was awarded a plaque from City Councilman Lake Ray for starting a Neighborhood Watch Program in our neighborhood. He made Eagle Scout and now is in college.

Our faith has kept us strong on many dark days. We thank Ted Hires and the Justice Coalition for publishing Paul's picture and reward in the *Victims' Advocate*. It gives us hope that his cold case will be solved.
