**Name:** Helen Walker

**Info:** At approximately 5:10 a.m. on Oct. 5, an unknown suspect entered the Best Western Hotel, 4580 Collins Road, approached the clerk, 34-year old Helen Walker, and inquired about a room. He then produced a handgun and robbed her, shot and killed her and fled the scene on foot.

**Name:** William I. Bowden, III, was found shot on Nov. 10 at 4752 Radcliff Court. He later died from his injuries. Detectives are looking for a black male driving a 2000 or 2001 beige Toyota Camry. 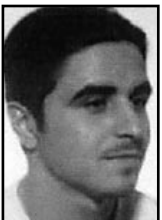

**Info:** Beloved father and grandfather was murdered on May 5, 1996, around 5:30 a.m.

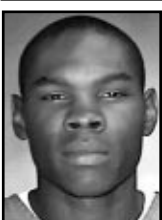
