Domestic Violence

— FL Statute 741.28-741.31. Any assault, aggravated assault, battery, aggravated battery, sexual assault, sexual battery, stalking, aggravated stalking, or any criminal offense resulting in physical injury or death of one family or household member by another who is or was residing in the same single dwelling unit as domestic violence. A family or household member includes spouses, former spouses, persons who are presently residing together as a family, or who have a child in common regardless of whether they have been married or have resided together at any time.

- **DOMESTIC VIOLENCE**, is, in most instances a learned behavior, a "family tradition" passed down from generation to generation.

- **DOMESTIC VIOLENCE** is a crime that happens in all classes and races. It crosses all income and educational levels. EACH YEAR MILLIONS of women, men and children are victims of our nation's most unreported crime – domestic violence. It causes physical and emotional injuries and teaches women, men and children to live in fear. Domestic violence destroys love and trust and it destroys relationships.

- **DOMESTIC VIOLENCE** can take different forms, but its goal is always the same. Batterers want to control their domestic partners through fear. They do this by regularly abusing them physically, sexually, psychologically and economically.

- You may ask the State Attorney to **FILE A CRIMINAL COMPLAINT**.

- **YOU HAVE THE RIGHT TO GO TO COURT AND FILE A PETITION** requesting an injunction for protection from further violence which may include, but need not be limited to, provisions which restrain the abuser from further acts of abuse; direct the abuser to leave your household; prevent the abuser from entering your residence, school, business, or place of employment; award you custody of minor child/children and direct the abuser to pay support to you and the minor children if the abuser has a legal obligation to do so.

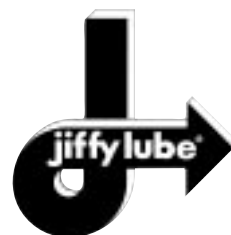
